Entry Fee: \$5 (Entrants must be a member of Missouri Fiber Artists – see website and follow directions.)

Juror: Stefanie Kirkland is currently the Deputy Director of Craft Alliance, managing the entire exhibition program, and acting as liaison between artists and Craft Alliance. She holds the additional title of Director of the Artists-in-Residence Program. As mentor, she assists artists to navigate their careers. The intriguing shop at Craft Alliance is also Kirkland's responsibility.

Craft Alliance has recently moved to a new and larger location, 5080 Delmar Blvd, St. Louis, MO.

Kirkland earned an MFA from the Academy of Art University, San Francisco, CA, (summa cum laude), a BFA from Syracuse University, Syracuse, NY and studied Painting, Art History and Printmaking at the American University, Corciano, Italy.

Through training as both a fiber artist and painter, her work incorporates aspects from each media, focusing on enhancing the subject matter through mixed media techniques. Stefanie's work has been shown nationally and is in various private collections.

Instructions and Restrictions:

Currently enrolled student, Minimum 18 years old

Works must be the original concept of the artist

Awards of Excellence will be given

Artist must be a member of Missouri Fiber Artists, see website to join Artworks ready to install, i.e. wires on frames, hanging rods in sleeves or casings

Windows are 54"H x 137"W x 54"D

No organic materials are allowed

3D artworks are encouraged

Light weight items can be hung from the metal grid at the ceiling of the window

A few larger works can be hung on the side and back walls of the window There is no restriction as to when artwork was completed

Artist may submit only 1 entry with 1, 2 or 3 items

Windows are west facing, but are shaded by an adjacent building.

Security: Artworks will be stored in a secure closet with supervision before installation and within a locked window area while on display.

Artworks are to be insured by the artist until they reach the Saint Louis Artists' Guild. No other insurance will apply from the time it leaves the artist's hands, until it reaches the SLAG. All reasonable care will be taken with your works. MoFA, nor MoFA members, nor the Saint Louis Artist Guild or staff can be held responsible for theft or damage.

Publicity: Missouri Fiber Artists and the Saint Louis Artists' Guild reserve the right to photograph the display, and use your submitted photographs, for reproduction in color or black and white, of all artworks submitted to *Windows to the Future - Showcase of Student Works*, for educational and publicity purposes, regardless of copyright.

Insurance: All of the Artist's work consigned to SLAG will be insured by SLAG for 65% of the retail price for the Artist. Set prices using this information.

Any loss or damage that occurs while the work is in SLAG's possession which is not covered by insurance will be covered by SLAG provided that SLAG's liability under this paragraph is limited to the amount which would have been due the Artist if the work had been sold at the price stated herein. Artist must provide evidence of comparable sales or appraisal if there is a loss.

Commission: Artist's work shall be held on consignment with the SLAG and offered for sale at the retail price provided by the artist. SLAG will receive 35% of the retail sale price and the Artist will receive 65%. Except as agreed upon in writing by SLAG and Artist. No discounts shall be given by the SLAG without artist's permission and any discounts will be split between the SLAG and the artist's percentage of retail. Artwork does not have to be for sale, but artists must provide a retail value. Artist's work is and shall remain the sole property of Artist until sold.
